1. Purpose and Parties

This Agreement is between Holistic Healing 4 Life ("HH4L") and the business identified above (the "Business Ambassador"). Its purpose is to create a community partnership through which the business may share HH4L membership information, provide an approved member benefit or special offer, and explore optional business perks. The Business Ambassador may sign this Agreement when ready; a meeting with Eva is part of onboarding and is not required before the business decides to participate.

2. Independent Relationship

The Business Ambassador remains an independent business. This Agreement does not create employment, a franchise, partnership, joint venture, agency, or authority to bind the other party. Each party remains responsible for its own operations, taxes, licenses, insurance, advertising claims, staff, customers, records, and legal compliance.

3. HH4L Support

- Provide the HH4L membership brochure and approved information that the business may display or share.
- Confirm the business's member benefit or special offer before it is published or promoted.
- When mutually agreed, provide visibility through HH4L community outreach, events, website listings, or representative introductions.
- Explain optional business-growth perks and connect the business with the appropriate outside company or application process.

4. Business Ambassador Responsibilities

- Display or share current HH4L membership information accurately and discontinue outdated materials when HH4L provides replacements.
- Choose and honor the written member benefit or special offer stated in this Agreement, subject to any stated limits.
- Obtain voluntary permission before collecting or using customer contact information and send only permission-based messages.
- Avoid promising customers or other businesses revenue, referrals, financing approval, CareCredit enrollment, savings, health results, or any other guaranteed outcome.
- Notify HH4L promptly of changes to contact information, the approved offer, or participation status.

5. Member Benefit and Publication Approval

The Business Ambassador selects the exact offer that works for its business. The offer may be a discount of up to 25% or another clearly described special benefit. Nothing will be published or promoted until the final wording, limits, contact information, and participation details are confirmed by both parties.

6. Optional Business Benefits and Perks

The items below are optional and are not required for HH4L Ambassador participation. Each has a separate enrollment, qualification, approval, fee, guarantee, and/or written-terms process with the outside provider.

- Customer database: Explore a permission-based phone database for reminders, events, classes, follow-up, and special offers. Any SenText pricing, equipment, support, or money-back guarantee is controlled only by SenText's current written terms.
- Small-business funding: The HH4L representative's role is only to introduce the opportunity and help the business schedule a Calendly appointment directly with SenText Capital or the funding company. HH4L representatives do not discuss or promise approval, amounts, rates, timing, or terms.
- CareCredit: Explore whether the business may apply to accept CareCredit for eligible customer services. Enrollment, service eligibility, fees, approval, and terms are controlled by CareCredit.

7. No Guarantees and Customer Choice

Participation does not guarantee customers, referrals, revenue, funding, approval, event placement, website traffic, database growth, CareCredit enrollment, or any other result. Customers remain free to choose whether to join HH4L, use the Business Ambassador, accept an offer, or participate in any optional program.

8. Term and Ending Participation

This Agreement begins when signed by the Business Ambassador and accepted by HH4L. It continues until either party ends participation by written notice. After notice, the business will stop presenting itself as an active HH4L Ambassador and HH4L will remove or update the listing and promotions within a reasonable time. Obligations involving prior customer consent, confidentiality, payment, or separate third-party agreements remain governed by the applicable written terms.

9. Complete Agreement and Changes

This Agreement and the completed participation details contain the parties' understanding about HH4L Ambassador participation. Changes must be confirmed in writing. Electronic or typed signatures and copies may be treated as originals. The business may sign before meeting Eva; HH4L's signature confirms acceptance and activates the relationship.
